NOTICE INVITING TENDER

Assistant High Commission of India, Khulna invites Tender under two bid system from firms for Supply, Installation, Testing and Commissioning of Closed Circuit Television (CCTV) Camera system in Assistant High Commission of India, Khulna.

- 2. The tender documents can be downloaded from the websites https://www.ahci.khulna@mea.gov.in. No tender fee will be charged for the tender documents. Please note that any corrigendum/addendum in the above tender documents, if required, will be hosted in the website of the Assistant High Commission of India, Khulna as mentioned above.
- 3. The interested firms should submit the bids in two separate sealed covers, super scribed as "Technical Bid" and "Financial Bid". Both sealed covers should be put in a single enveloped super scribed as "Tender No. **KHU/ADM/871/01/2019** for Supply, Installation, Testing and Commissioning of Closed Circuit Television (CCTV) Camera system" and addressed to "Assistant High Commissioner, Assistant High Commission of India, Khulna, 65 Shamsur Rahman Road, Khulna-9100". Please note that no tender documents will be accepted after the expiry of stipulated date and time for the purpose under any circumstances.
- 4. The Earnest Money Deposit (EMD) of BDT 1,50,000/- (BDT One Lakh Fifty Thousand only) in the form of Demand Draft/Pay Order in favour of the "Assistant High Commission of India, Khulna" is required to be submitted along with the Technical Bid. Bids shall not be considered in case the EMD is not submitted and would be rejected summarily.
- 5. The Technical Bids will 18.02.2024 bv a Committee be opened on duly constituted by the Competent Authority of the Assistant High Commission of India, Khulna. The financial bids of only those bidders, whose Technical Bids are found responsive, shall be opened by the Committee authorized for the purpose.
- 6. The Competent Authority reserves the right to reject any or all the bids, or cancel the tender, without assigning any reason and the decision of the competent authority of the Assistant High Commission of India, Khulna shall be final and binding.

SECTION II

INSTRUCTIONS TO BIDDERS (ITB)

1. Implementation period/Timelines

The complete implementation must be carried **within 1 months** after Award of Work.

2. Locations for the Supply, Installation & Warranty Services

The construction material/equipments covered under this document shall be supplied at the project location with **nationwide warranty for a period as provided by the OEM firm for a duration as mentioned in the Annexure A to Annexure J.**

3. Order Placements and Release of Payment

The Work Order and payment shall be processed by:

Assistant High Commissioner Assistant High Commission of India, Khulna

4. Amendment of Bidding Documents

At any time prior to the deadline for submission of bids, AHCI, Khulna may, for any reason, whether on its own initiative or in response to the clarification request by a prospective bidder, modify the bid document.

5. Earnest Money Deposit (EMD)

- a. The tender documents must be accompanied by Earnest Money Deposit of appropriate amount, in the form of a Demand Draft (DD)/ Pay Order (PO) drawn on any Nationalized Bank, in favour of 'Assistant High Commission of India, Khulna'. The amount towards EMD is Tk.1,50,000/- [One Lakh Fifty thousand only] and should be submitted in the envelope containing Technical bid. Bids submitted without EMD will stand rejected. EMD will not be accepted in the form of cash/cheque/ FDR/ BG or any other form except DD. No interest shall be payable on EMD.
- b. The EMD will be returned to the bidder(s) whose offer is not accepted by Assistant High Commission of India, Khulna within 30 days from the date of the placing of the final order(s) on the selected bidder(s).
- c. The successful bidder, on award of contract/order, must send the contract/ order acceptance in writing, within 7 days of award of contract/ order, failing which the EMD will be forfeited and the order will be placed to the next successful bidder.

d. The EMD shall be forfeited:

- i) If the bidder withdraws the bid during the period of bid validity specified in the tender.
- ii) In case a successful bidder, fails to furnish the Performance Bank Guarantee
- iii) If the bidder fails to furnish the acceptance in writing, within 7 days of award of contract/ order.
- iv) Fails or refuses to honour his own quoted prices for the services or part thereof

6. Preparation and submission of Bids:

a. Two-bid system will be followed for this tender. In this system, bidder must

submit his offer as explained below.

b. Envelope No. 1: "Technical Bid":

- (i) Duly filled Technical bid with proper seal and signature of authorized person on each page of the bid and tender document should be submitted in duplicate.
- (ii) All the necessary documents including those in support of Minimum Eligibility Criteria should be submitted with Technical Bid. These documents should be self attested.
- (iii) Compliance of Technical Specifications mentioned in Annexure \boldsymbol{A} to Annexure J.
- (iii) Earnest Money Deposit should be submitted with the "Technical Bid".

c. Envelope 2: "Financial Bid":

- (a) Tender Submission Sheet as per Annexure- 1,
- (b) No other documents except "Price Schedule" may be submitted along with Financial Bid otherwise the bid shall stand rejected.
- (c) All amounts are to be quoted only in Bangladeshi Taka. The price quoted in the Financial bid shall be considered final and no price escalation will be permitted.

The Bid shall be neatly arranged, plain and intelligible and the language of the Bid should be English. Each page of the bid should be signed. They should not contain any terms and conditions, printed or otherwise, which are not applicable to the Bid. The conditional bid will be summarily rejected. Insertions, postscripts, additions and alterations shall not be recognized, unless confirmed by bidder's signature.

The bidder, as part of its Technical bid, will submit its company profile and information regarding its key personnel, per Annexure-5 of this tender document, with supporting documents such as copy of National ID, etc.

7. Period of validity of bids

- e. Bids shall be valid for a minimum 180 days from the date of submission of bids. A bid valid for a shorter period shall stand rejected.
- f. AHCI Khulna may ask for the bidder's consent to extend the period of validity. Such request and the response shall be made in writing only. The bidder is free not to accept such request without forfeiting the EMD. A bidder agreeing to the request for extension will not be permitted to modify his bid.

8. Performance Bank Guarantee

- a) The successful bidder has to deposit Performance Bank Guarantee in the form of a Demand Draft/Pay Order/ Bank Guarantee drawn in favour of the Assistant High Commission of India, Khulna payable at Khulna. If it is Bank Guarantee, the same should be as per the format given in Annexure-4 to this tender document.
- (b) Performance Bank Guarantee will be of an amount equivalent to 5% (five percent) of the total Contract Price.
- (c) Performance Bank Guarantee should be submitted within fifteen (15) days of signing of Contract Agreement.
- (d) This bank guarantee shall remain valid till the completion of warranty period/defect liability period.

(e) No interest shall be payable on Performance Bank Guarantee.

9. Late Bids

Any bid inadvertently received by AHCI, Khulna after the deadline for submission of bids, will not be accepted and returned unopened to the bidder.

10. Award of Contract

Award Criteria:

- a. AHCI, Khulna shall award the contract to the eligible bidder whose technical bid has been accepted and determined as the lowest evaluated commercial bid.
- b. The lowest price criteria shall be applied on the total.
- c. If more than one bidder happens to quote the **same lowest price**, **AHCI**, **Khulna** reserves the right to split the order and award the contract to more than one bidder.

11. Purchaser's Right to amend Scope of Work

If, for any unforeseen reasons, AHCI, Khulna is required to change the Scope of Supply, this change shall be acceptable to the bidder without change in the unit price quoted.

Interpretation of the clauses in the Tender Document/Contract Document in case of any ambiguity/dispute in the interpretation of any of the clauses in this Tender Document, AHCI Khulna's interpretation of the clauses shall be final and binding on all parties.

12. Cancellation of Tender

The Assistant High Commission of India, Khulna reserves the right to cancel the tender or re-tender at any stage for security reasons or for any other reason as decided by the Competent Authority.

SECTION III:

SPECIAL CONDITIONS OF CONTRACT (SCC)

1. **The Location:** The project shall be executed at the Chancery complex of the Assistant High Commission of India, Khulna, 65-Shamsur Rahman Road, Khulna-9100. A site visit and pre-bid meeting will be held in the above mentioned address on 01.02.2024. Prospective bidders are expected to visit the site and attend the pre-bid meeting. In any case, the tenderer shall be deemed to have visited the site and have full knowledge of the site in all respects before submitting the bids.

2. Prices

- a. The price quoted shall be considered firm and no price escalation will be permitted.
- b. Bidders must quote the price in the format given in Annexure-1
- c. All items are to be quoted only in Bangladeshi Taka.
- d. The prices quoted should be inclusive of freight, insurance, packing, distribution, after sales service, applicable taxes.

3. Work Schedule

Upon award of contract, the successful bidder should submit a work schedule indicating the time lines.

4. Project Monitoring Committee

Payments would be released by Assistant High Commission of India, Khulna upon certification of bills by Project Monitoring Committee constituted to monitor the progress of work.

5. Taxes and Duties

The prices quoted should be inclusive of freight, insurance and other taxes (VAT) till project location. However, the bidder should insure the consignment till actual delivery to the Assistant High Commission of India, Khulna.

6. Performance Bank Guarantee (PBG):

The successful bidder will be required to furnish the Performance Bank Guarantee in form of a Bank Guarantee for the 5 % (Five percent) amount of the Purchase Order within 15 days of receipt of Purchase Order, as per the format attached to this document (Refer Annexure-5). This bank guarantee shall remain valid till the completion of warranty period/defect liability period.

7. Warranty:

All the items covered under the schedule of requirements, shall carry a warranty period as mentioned in the technical specifications in Annexure A to Annexure J as provided by the OEM firm of the said equipment from the date of installation/Commissioning/completion. The bidder must undertake to provide the installation and warranty service at Khulna. The repairing/rectification/replacement/configuration required, if any, of the items under warranty must be done at on site workshop.

8. Payments:

No advance payment will be admissible. Payment will be made only after installation and successful commissioning of the CCTV system to the AHCI, Khulna's satisfaction against submission of proper bills & invoices

9. Penalty for delayed Services:

- a. AHCI, Khulna reserves the right to levy penalty @ of 0.5% of total value of ordered items per day of delay beyond the scheduled deliveries/execution of the order successfully, subject to maximum of 5% of the order value.
- b. AHCI, Khulna reserves the right to cancel the order in case the delay is more than 8 weeks.

10. Force Majeure:

AHCI may consider relaxing the penalty and delivery requirements, as specified in this document, if and to the extent that, the delay in performance or other failure to perform its obligations under the contract is the result of an Force Majeure. Force Majeure is defined as an event of effect that cannot reasonably be anticipated such as acts of nature (like earthquakes, floods, storms etc.), acts of states, the direct and indirect consequences of wars (declared or undeclared), hostilities, national emergencies, civil commotion and strikes at successful Bidder's premises.
